DIRECTIONS FOR USE USE ONLY AS DIRECTED.

Shake well before use.
Mix 50ml of the Pulvex® Dog Dip with 10 litres of water (100ml:20 litres) in a suitable bath. Stir well to obtain a good mixture. Submerge the dog up to the neck in the dip solution and wet to skin level. Do not rub or scrub the dip into the dog's skin. Rinse the head but avoid direct contact with the eyes and mouth. Remove the dog from the bath and allow to dry naturally. Do not rinse with water.

FREQUENCY OF USE

Repeat as needed, i.e. weekly, depending on the tick or flea challenge.
